These Terms of Use (the "Terms") govern your use of our website(s), products, services and applications (the "Services"), specifically our online marketplace platform for listing businesses for sale and connecting potential buyers and sellers. These Terms are a binding contract between you and ZOKAAI, ("zokaai," "we" and "us"). You must agree to and accept all of the Terms, or you don't have the right to use the Services. Your using the Services in any way means that you agree to all of these Terms, and these Terms will remain in effect while you use the Services. These Terms include the provisions in this document, as well as those in the Privacy & Cookies Policy and Copyright Dispute Policy.

1. Scope of Services

zokaai operates an online marketplace platform that allows business owners ("Sellers") to list their businesses for sale and potential buyers ("Buyers") to browse and search for businesses. We may also offer tools and resources to facilitate the buying and selling process.

zokaai is NOT a business broker, financial advisor, or legal representative. We do not provide advice or represent either Buyers or Sellers in any transaction. Our role is solely to provide a platform for connection and information.

2. Disclaimer of Liability

ZOKAAI DOES NOT VERIFY THE ACCURACY, COMPLETENESS, OR RELIABILITY OF ANY INFORMATION PROVIDED BY SELLERS IN BUSINESS LISTINGS. BUYERS ARE SOLELY RESPONSIBLE FOR CONDUCTING THEIR OWN INDEPENDENT DUE DILIGENCE, INCLUDING FINANCIAL, LEGAL, AND OPERATIONAL REVIEWS, BEFORE MAKING ANY DECISIONS RELATED TO PURCHASING A BUSINESS. ZOKAAI IS NOT RESPONSIBLE FOR ANY LOSSES OR DAMAGES INCURRED AS A RESULT OF RELIANCE ON INFORMATION PROVIDED ON OUR PLATFORM.

3. User Responsibilities

TO THE FULLEST EXTENT PERMITTED BY APPLICABLE LAW, ZOKAAI SHALL NOT BE LIABLE FOR ANY INDIRECT, INCIDENTAL, SPECIAL, CONSEQUENTIAL, OR PUNITIVE DAMAGES, INCLUDING BUT NOT LIMITED TO, LOSS OF PROFITS, LOSS OF BUSINESS, LOSS OF OPPORTUNITY, LOSS OF DATA, OR OTHER INTANGIBLE LOSSES, ARISING OUT OF OR RELATING TO YOUR USE OF THE SERVICES, EVEN IF ZOKAAI HAS BEEN ADVISED OF THE POSSIBILITY OF SUCH DAMAGES. 15. Dispute Resolution

These Terms are governed by the laws of New South Wales, Australia, without regard to its conflict of law principles. We hope to resolve any disagreements amicably. However, if a

dispute arises, it will be settled through arbitration in Sydney, Australia, following the Streamlined Arbitration Rules of the Australian Centre for International Commercial Arbitration (ACICA). This process involves a neutral arbitrator with experience in commercial disputes, and the decision will be final and binding. You and zokaai each give up the right to a jury trial and the ability to participate in a class action lawsuit.

This does not prevent either party from seeking urgent injunctive or equitable relief in the courts of Sydney, New South Wales, to prevent immediate harm. The courts in Sydney, New South Wales, will have exclusive jurisdiction for such actions.

16. Changes to these Terms

We are constantly trying to improve our Services, so these Terms may need to change along with the Services. We reserve the right to change the Terms at any time, but if we do, we will bring it to your attention by placing a notice on the zokaai.com website, by sending you an email, and/or by some other means.

If you don't agree with the new Terms, you are free to reject them; unfortunately, that means you will no longer be able to use the Services. If you use the Services in any way after a change to the Terms is effective, that means you agree to all of the changes.

Except for changes by us as described here, no other amendment or modification of these Terms will be effective unless in writing and signed by both you and us.

17. Governing Law and Jurisdiction

The courts in Sydney, New South Wales, will have exclusive jurisdiction.
